

## THE FTC COVENANT

## Our part:

- FTC will put its resources into staging the best show possible and drawing an audience for each performance.
- We will begin and end rehearsals on time.
- We will not schedule rehearsals or performances other than that on the printed schedule without first checking with the cast.
- The FTC staff will teach you, support you, and encourage you to become the best performer you can be, and provide the opportunity for you to give your best performance each time.

## Your part:

- To be present for every rehearsal called for your part unless you've informed us prior or are prevented by an emergency.
- To be on time for rehearsals and stay until dismissed by the director.
- To maintain a strong work ethic in rehearsals, staying focused and attentive to the director.
- To learn your lines as soon as possible and to meet the deadline set by the director for having the play memorized.
- To work on your part outside of rehearsal.

I agree to the above terms and conditions:

- To contribute to the supportive and encouraging environment by helping the production in any way prior, during, and after the performance.
- To say only encouraging things to or about a fellow player.
- To avoid doing anything inappropriate on the stage or backstage that could distract your fellow players or jeopardize the product we present to our audiences.
- To, at all times while on FTC property, avoid any and all inappropriate behavior, or even the appearance of impropriety, in matters including, but not limited to, offensive language, uninvited touching, sexual comment, innuendo or suggestion, or any conduct that would negatively impact the creative environment of FTC, with the understanding that failure to adhere to these guidelines may result in removal from the property and/or participation in FTC productions.
- All representatives of FTC (including cast, crew, staff and on-duty volunteers) will not consume alcohol while "on duty" at the theater. These duties include rehearsals; performances, constructions, preparations and any other FTC sanctioned events.
- You understand that live theater is a complex process including, among many other activities, set building, lighting, elevation changes, handling of props, set and scene changes, often in a darkened environment, and a variety of other unique activities requiring you to be at your full attention to ensure your safety and that of your fellow volunteers. Notwithstanding this understanding, by signing the FTC Covenant you also are knowingly releasing FTC for any and all liability for personal injury, property damage, economic damages, disability and any other incidental or consequential damage that you might assert, arising from, or in any manner pertaining to any transaction or occurrence involving you and FTC. Further, by signing the FTC Covenant, you are representing to FTC that you have secured for yourself adequate health, hospitalization and disability, including economic disruption, insurance to ensure your wellbeing in any eventuality.
- The participant acknowledges and will reasonably facilitate any personal background check deemed appropriate by FTC, in its sole discretion, prior to assuming any duties or responsibilities.
